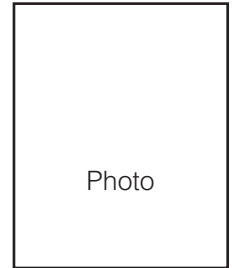

# INFORMATION SHEET

## SOCIAL VISA (MULTIPLE ENTRY)

Duration of Validity: (3) months, (6) months and (1) year from date of issue.

- Multiple VISA are entitled for those who got Social Single VISA before that.
- **Applicants must illustrate the required type of MJEV.**
- Period of stay in Myanmar restricted to 70 Days from date of arrival. It can be extended.

A spouse (a foreigner who married with Myanmar Citizen) of a Myanmar National, children of a Myanmar National and a Foreigner, or those who surrendered Myanmar Citizenship are allowed to apply only for a social visit visa. A Singaporean residing in Singapore can apply for a visa at the Myanmar Embassy. Other nationalities will be considered case by case for issuance of a social visit visa. The applicant (Singaporean, ex-Myanmar only) who needs visa urgently must provide strong evidence of letter, i.e. death certificate of applicant's kin, together with air ticket. The application deadline is before 3:30 pm in order to process from our office. Timely receipt of these documents is important and any late application and without evidence of letter will not accept for visa consideration.

## DOCUMENTS REQUIRED FOR SOCIAL VISA

1. Appointment letter (online Q number)
2. One copy of duly-filled Social Visit Visa application form. False signature may result in non-acceptance at the Visa counter
3. Describe completely and correctly the address in Myanmar where you will stay, the name of a sponsor in Myanmar, and the reason to visit
4. THREE recent photos of 1.5 x 2 inches with white color background (Scanned photos are not allowed, without any Glasses & photo must be taken in 6 month time)
5. Passport with minimum validity of Six months & two full empty pages
6. Applicant's Name Card/ Business Card
7. Photocopy of the first page of passport with the applicant's photo shown.
8. A photocopy of IC/ PR (with Re-Entry Form-7)/ EP/ Student Pass ( Both sides)
9. Copy of Birth certificate or other concrete documents for an applicant who need to prove he/she was born of Myanmar citizen (or) the applicant is under 15 years old
10. Copy of marriage certificate for an applicant who married with Myanmar citizen
11. VISA fees S\$ 265 (For MJEV 3months) , S\$ 525 (For MJEV 6months), S\$ 790 (For MJEV 1 Year)
12. Applicants may be asked to provide other documents if and when necessary

## TIME

- Visa application submission : Monday to Friday, From 8:30 am to 12:00 pm (noon)
- Visa Collection : Monday to Friday, From 4:00 pm to 5:00 pm
- Visa Processing Time : 1 working day in most cases
- We strongly recommend that visa applicants should not purchase flight tickets or make unchangeable travel plan before obtaining visa

## NOTES

1. On the appointment date, please come to Myanmar Embassy at 8:30 am.
2. Make sure you bring all required documents listed above. Your application may not be accepted if you cannot present all required documents.
3. If you do not have long term stay permit in Singapore, your application will not be accepted.
4. When you are arrived Embassy, please wait for your queue number. Once your queue number is called, proceed to visa application counter and submit your application with required documents.
5. If your application is accepted, you will pay visa fees and visa processing fees. Authorized staff will issue a receipt and your application submission process will be completed.
6. You can collect your passport on the same working day between 4:00 pm and 5:00 pm.
